As we have discussed before it is rare for you to be on the defence journey from day one and I am ever so thankful we met at Lewes Crown Court that time when I saw you celebrating with a client and looking back encompassing the Barrister you are.

When I left that first meeting of ours I knew you were the captain of the ship I needed. Your supportive, caring and overall demeanour was reassuring yet subjective and I left Lewes feeling somewhat more upbeat having been requisitioned to court.

Without this advice, I wouldn't have a business that I do today and would be in a very different set of circumstances without that advice.

The second trial this year was a totally different experience, being D1 was a fairly daunting prospect but you allayed my worries with your honesty and explanations allowing me to process the journey much better than I thought possible.

Although much of the work had been done in the first trial your attention to detail and work ethic was humbling and I am in awe of your talent as a Barrister. Your examinations are considered and strategy based, your character is extremely well received in court and your understanding of the legal system is mind bending.

As nervous as I was when that tannoy called us to court for the verdict I was at peace knowing that I had tried my best and in the comfort, you had been the one putting my case forward. I had no regrets with anything we had done in preparation and execution of my case.

Words really can't justify Quentin just how thankful I am for your work and support over the last three or four years. Simply put, I would not have been able to have come through this experience as I have without you.

I know you don't like receiving compliments but I hope reading this will be a little easier for you to digest and appreciate just how talented and unique you are.
